Sir,

Inviting reference to this office above cited letter (Copy enclosed) requesting you to revise Pension/ Family Pension in respect of Pre-2016 pensioners/ Family Pensioners w.e.f. 01.01.2016 due to implementation of 7th CPC recommendation in ICAR and disburse revised Pension as per guidelines from August 2017 in terms of ICAR Letter No. FIN/ 10/ 02/ 2017- Pension dated 31.08.2017 (Copy enclosed) where in it was stated that the payment of arrears on account of revision of Pension/ Family Pension for the period from 1st January 2016 to 31st July 2017 will however be made in view of orders to be issued separately by the Council.

In this connection, it is stated that the Council Vide Letter No. **FIN/10/02/2017 - Pension dt. 15.02.2018** (Copy enclosed) has issued orders for payment of arrears on account of revision of Pension/ Family Pension to pre-2016 Pensioners/ Family Pensioners w.e.f. 01.01.2016 onwards.

The revised authorization for payment of Pension/ Family Pension w.e.f. 01.01.2016 at enhanced rate due to implementation of 7th CPC recommendation is under process and will be issued for your record. But till then you are requested to fix revised Pension/ Family Pension in respect of Pre- 2016 Pensioners/ Family Pensioners **using multiple of 2.57 of Pension/ Family Pension fixed under 6th CPC in terms of Para No. 4.1 of Govt. of India , Ministry of Personnel, Public Grievances Pension , Dept. of Pension & Pensioners welfare O.M. No. 38/37/2016- P&PW (A) (ii) dt. 04.08.2016 (Copy enclosed).**

Further, it is intimated that ICAR vide its letter under reference has requested to ensure the difference of Pension due to revision **may be paid before 31.03.2018** so that the related liability is settled within the current Financial Year. Medical Allowance has also been revised to Rs. 1000/- p.m. from July 2017 onwards for which order issued separately. However, it enhanced Medical Allowance of Rs. 1000/- not paid from July 2017 the same may be paid as arrear.

In view of the above, you are therefore requested to **advise all branches of SBI, being link Branch of ICAR-CIFRI for payment of difference of Pension/ Family Pension to pre-2016 Pensioners / Family Pensioners due to revision as per 7th CPC w.e.f. 01.01.2016 before 31.03.2018 positively as per instruction of Council in order to settle the related liability within the current Financial Year i.e.2017-18.**

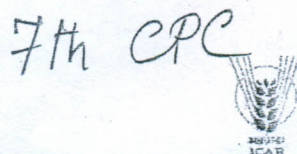


The undersigned is directed to state that the Competent Authority has approved the proposal for implementation of the decision of the Government of India for revision of pension/family pension and other retirement benefits in terms of the Council's Pensioners/family Pensioners in respect to pre-2016 Pensioners/family Pensioners and those having retired/died in harness after 01.01.2016 and up to implementation of 7th CPC in Council whose pay has been revised in terms of Council's O. M. F. No. FIN/21/01/2017-CDN (A&A) dated 19.01.2017.

2. It has been decided to initiate action to revise pension/family pension of Council's Pensioners/family Pensioners according to the recommendations of 7th CPC. **The payment of revised pension/family pension may be made w. e. f. August, 2017 onwards.**

3. **The payment of arrears on account of revision of pension/family pension for the period 01st January 2016 to 31st July 2017 will however be subject to specific budgetary provision by the Council, for which orders will be issued separately.**


The undersigned is directed to state that instructions were issued vide communication of even number dated 31st August, 2017 regarding payment of revised pension/family pension to Council's pensioners/family pensioners according to the recommendations of 7th CPC. The payment of revised pension/family pension to all categories was made w. e. f. August, 2017 onwards.

2- As per instructions contained therein, the payment of arrears on account of revision of pension/family pension for the period from 01.01.2016 to 31.07.2017 was kept withheld subject to specific budgetary provision by the Council.

3 It has now been decided with the approval of the Competent Authority in the Council to release the payment of arrears on account of revision of pension/family pension for the period from 01.01.2016 to 31.07.2017 to Pre-2016 pensioners/family pensioners and other difference of retirement benefits in terms of the Council's Pensioners/family Pensioners to those having retired/died in harness after 01.01.2016 and up to implementation of 7th CPC in Council whose pay has been revised in terms of Council's O.M. F. No. FIN/21/01/2017-CDN (A&A) dated 19.01.2017.

4 The revision of pension/family pension of pre-2016 pensioners/family pensioners and other retirement benefits may be carried out as per GoI instructions, including those contained in DoP&PW order dated: 12.05.2017, as endorsed by ICAR and the difference may be paid before 31.03.2018 so as to ensure that the related liability is settled within the current financial year.

OFFICE MEMORANDUM

Sub: Implementation of Government's decisions on the recommendations of the Seventh Central Pay Commission - Revision of pension of pre-2016 pensioners/family pensioners etc.

The undersigned is directed to say that in pursuance of Government's decision on the recommendations of Seventh Central Pay Commission, sanction of the President is hereby accorded to the regulation, with effect from 01.01.2016, of pension/ family pension of all the pre-2016 pensioners/ family pensioners in the manner indicated in the succeeding paragraphs. Separate orders are being issued in respect of employees who retired/died on or after 01.01.2016.

2.1 These orders shall apply to all pensioners/family pensioners who were drawing pension/family pension before 1.1.2016 under the Central Civil Services (Pension) Rules, 1972, Central Civil Services (Extraordinary Pension) Rules and the corresponding rules applicable to Railway pensioners and pensioners of All India Services, including officers of the Indian Civil Service retired from service on or after 1.1.1973. A pensioner/family pensioner who became entitled to pension/family pension with effect from 01.01.2016 consequent on retirement/death of Government servant on 31.12.2015, would also be covered by these orders.

2.2 Separate orders will be issued by the Ministry of Defence in regard to Armed Forces pensioners/family pensioners.

2.3 These orders also do not apply to retired High Court and Supreme Court Judges and other Constitutional/Statutory Authorities whose pension etc. is governed by separate rules/orders.

3. In these orders :

- a. 'Existing pensioner' or 'Existing Family pensioner' means a pensioner/family pensioner to whom these orders are applicable in terms of para 2.1 above.
- b. 'Existing pension' or 'Existing Family Pension' means the basic pension (inclusive of commuted portion, if any) or basic family pension, as had been fixed at the time

of implementation of 6th CPC recommendations, which an existing pensioner or family pensioner was entitled to.

4.1 For existing pensioners, who have retired before 01.01.2016, the revised pension/family pension with effect from 01.01.2016 shall be determined by multiplying the pension/family pension, as had been fixed at the time of implementation of 6th Central Pay Commission (CPC) recommendations, by 2.57. The amount of revised pension/family pension so arrived at shall be rounded off to next higher rupee.

Illustration:

✓ Case I

Pensioner 'A' retired at last pay drawn of Rs. 79,000 on 31st May, 2015 under the 6th CPC regime in the scale of Rs. 67000-79000:

1	Basic Pension fixed in 6 th CPC	39500
2	Revised Pension fixed under 7 th CPC (using a multiple of 2.57)	101515

Case II

Pensioner 'B' retired at last pay drawn of Rs. 4,000 on 31st January, 1989 under the 4th CPC regime in the pay scale of Rs. 3000-100-3500-125-4500:

1	Basic Pension fixed in 4 th CPC	1940
2	Basic Pension as revised in 6 th CPC	12600
3	Revised Pension fixed under 7 th CPC (using a multiple of 2.57)	32,382

4.2 For this purpose, the existing pension/family pension will be the basic pension/family pension only without the element of additional pension available to the old pensioners/family pensioners of the age of 80 years and above. The additional pension/family pension payable to the old pensioners/family pensioners will be worked out in accordance with para 4.5 of this O.M.

4.3 Since the consolidated pension will be inclusive of commuted portion of pension, if any, the commuted portion will be deducted from the said amount while making monthly disbursements.

4.4 The minimum pension with effect from 01.01.2016 will be Rs. 9000/- per month (excluding the element of additional pension to old pensioners). The upper ceiling on pension/family pension will be 50% and 30% respectively of the highest pay in the Government (The highest pay in the Government is Rs. 2,50,000 with effect from 01.01.2016).
