13. The fish seeds should be securely packed and dispatched, freight Pre-Paid to the addressee.
14. This Institute will not be responsible for any loss or damage of live fish seeds in transit.
15. Your pre-receipted bill in triplicate (giving complete specification of equipment/machinery etc.) drawn in the name of "The Director, Central Inland Fisheries Research Institute, Barrackpore, Kolkata – 700 120, West Bengal be sent to the consignee together with the supporting documents/certificate /vouchers/delivery receipts/any bill etc. for arranging payment.

16. Payment will be made through e-transfer after satisfactory supply of live fish seeds at site. Please furnish your Bank Details duly signed by the Bank Authority (Mandate Form) for making payment through e-transfer/NEFT.

An amount at the rate of 0.5% per week or part thereof subject to a maximum of 10% of the cost will be collected from you delayed supply.


