- The items supplied shall be guaranteed for satisfactory performance for a period of at least 1 Year 3. from the date of satisfactory installation.
- The article should be securely packed and dispatched. 4.
- This Institute will not be responsible for any loss or damage of article in transit. 5.
- Your pre-receipted bill in triplicate drawn in the name of "The Director, Central Inland Fisheries Research Institute, Barrackpore, Kolkata-700120, West Bengal" may be sent to the consignee 6. together with the supporting documents/certificate/vouchers/delivery receipts/challan etc. for arranging payment after obtaining satisfactory installation certificate from the Consignee.
- Payment will be made through e-transfer after satisfactory completion of the supply and installation of materials. Please furnish your Bank Details along with the Bill duly signed by the 7. Bank Authority for making payment through e-transfer (RTGS/NEFT/PFMS).
- Where Taxes, duties are agreed to be paid in addition to the rates accepted, it will be paid subject 9. to fulfillment of the following condition:-
