Your pre-receipted bill in triplicate mentioning your Bank details therein (giving complete specification of equipment/machinery etc.) drawn in the name of "The Director, ICAR-Central Inland Fisheries Research Institute, Barrackpore, Kolkata -700 120, West Bengal" may be sent to the consignee together with the supporting documents/certificate/vouchers/ delivery receipts/ any bill etc. for arranging payment.

5. Payment will be made through e-transfer only after satisfactory completion of the supply and Installation of Equipment/Pens. Please furnish your Bank Details duly signed by the Bank Authority for making payment through e-transfer.
6. Where Taxes, duties are agreed to be paid in addition to the rates accepted, it will be paid subject to fulfillment of the following condition.
- (a) **GOODS & SERVICE TAX :-**


