TERMS & CONDITIONS

1. This Auction is non-transferrable.
2. The Earnest Money Deposit of Rs.5,000/- in form of Demand Draft drawn in favour of "ICAR Unit – CIFRI" payable at Barrackpore must be submitted along with the quotation.
3. Auction Fee of Rs.100/- (non refundable) in form of Demand Draft must be submitted along with the quotation.
4. The amount of bid for auction articles are to be quoted Lot wise separately.
5. The offer once submitted should remain valid for 30 days for acceptance.
6. The last date for the receipt of offers is **10.07.2017** up to 2.00 P.M. and will be opened the **same day at 3.30 P.M.**
7. The envelopes containing the offer etc. should be subscribed as **"Auction of Unserviceable Stores items for Allahabad Centre"**
8. Amount quoted will be treated as net price of the Lot on "as is where is basis". The award of Auction will be done Lot-wise on Maximum price quoted for that particular Lot.
