

3. AVAILABILITY OF THE EOI DOCUMENTS

EOI can be also downloaded from the Institute's website – www.cifri.res.in. The bidders are expected to examine all instructions, forms, terms, project requirements and other details in the EOI document. Failure to furnish complete information as mentioned in the EOI documents or submission of a proposal not substantially responsive to the EOI documents in every respect will be at the bidder's risk and may result in rejection of the proposal.

4. BIDDERS' CONFERENCE

The Institute will host a bidder's conference at the address given under Contact Details (Para.2) above. The Conference is tentatively scheduled as per the scheduled given in Para 3 above. The representatives of the interested firm may attend the bidders' conference at their own cost. The purpose of the conference is to provide bidders with any clarifications regarding the EOI. It will also provide each bidder with an opportunity to seek clarifications regarding any aspect of the EOI and the project. The venue for the bid conference will be at the address given in Para 2.

5. PROPOSAL SUBMISSION

The technical and financial proposal must be submitted in two separate sealed envelopes indicating clearly on envelopes as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**". Financial proposal to indicate a warning "**DO NOT OPEN WITH THE TECHNICAL PROPOSAL**". The envelopes containing the Technical and Financial Proposals shall be placed into an outer envelope and sealed. This outer envelope shall bear the title of the assignment "*Implementation of ISO 9001:2015 at ICAR-CIFRI, Barrackpore*".
