TERMS AND CONDITIONS:

- 1. Successful bidder must complete the work within 180 (One hundred eighty) days from the date of awarding the contract.
- 2. The site for the work is instantly available for initiation of the work.
- 3. Price must not be quoted in the Technical Bid, otherwise bid will be rejected.
- 4. The following documents in PDF Format are to be uploaded with the quotation through Central Public Procurement Portal (www.eprocure.gov.in).

- 6. Detailed specification/Scope of the work is enclosed in ANNEXURE- II.
- 7. The estimated cost of the work is ₹25,45,000.00 (Rupees twenty five lac forty five thousand only).
- 8. (i) Bid Security / Earnest Money Deposit (EMD) The bidder should submit Earnest Money Deposit of ₹51,000.00 (Rupees fifty one thousand only) in the form of Account Payee Demand Draft, Fixed Deposit Receipt, or Bank Guarantee from any Commercial Bank (drawn in favour of ICAR-Unit, ICAR-CIFRI, Barrackpore) OR through online mode in A/C. No- 11278713220 (Bank Account Name- State Bank of India, Branch- Barrackpore, IFSC Code SBIN0000029).
 - (ii)No exemption is allowed from submission of EMD as per works procurement policy.
 - (iii)EMD should be valid for a period of 45 days beyond the fixed Bid Validity
 - (iv) Bid Security/EMD of unsuccessful bidder will be returned within 30 days of technical evaluation.

- (v) If the Contractor fails to execute the work after receiving the award of the contract, the EMD will be forfeited.
- 9. The successful bidder will be required to furnish the Performance Security equivalent to 3% of the award value within 7(seven) days of receipt of Work Order. The Performance Security should be in form of Demand Draft / Fixed Deposit Receipt from a commercial bank/ Bank Guarantee issued from Commercial Bank/ or through online mode in A/C. No-11278713220 (Bank Account Name- State Bank of India, Branch- Barrackpore, IFSC Code SBIN0000029). The Performance Security will be retained for a period of 1(one) year and 6(six) months from the date of completion of the work. It will be refunded to the Contractor without interest, after duly performing and completing all obligations under the contract.
- 10. The Performance Security will be forfeited and credited to the Institute's Account in the event of a breach of contract by the Contractor.
- 11. Works are to be executed strictly as per the specifications mentioned in the Tender Document, failing which, payment will not be done. Works may be carried out without causing any damages to Government property. Such damages, if any needs to be compensated by the Contractor.
- 12. Tender once submitted will remain valid for 180 (one hundred eighty) days for acceptance.
- **13.** Any modification in the work schedule shall be informed to the Institute and subsequent payment for such works will be made accordingly on the basis of the final measurements on that specific item.
- **14.** Canvassing in connection with the tenders is strictly prohibited and the quotations submitted by the contractors who resort to canvassing will be liable to rejection.
- **15.** The online bid should contain two folders containing Technical Bid and Financial bid in the form of BOQ.
- **16.** The Director, ICAR-CIFRI, Barrackpore, Kolkata- 700 120 reserves the right to accept/reject any quotation or part thereof without assignment any reason.
- 17. Rate should be quoted inclusive of all taxes/duties/GST. No extra charges / taxes over and above the quoted rate in form will be borne by the ICAR-CIFRI. The rate will remain valid for 06 (six) months from the date of offer and no change in the rate shall be considered during this period.
- 18. The Tenderer shall be deemed to have visited the site of work before quoting their rate and no claim for any EXTRA PAYMENT on account of any misunderstanding etc. will be entertained by the Institute, irrespective of the fact whether they have actually the Site or not.
- **19.** An agreement will be entered into by the contractor with the Director, ICAR-CIFRI within 07 (seven) days of the issuance of the work order.
- 20. On acceptance of the tender, the name of the accredited representatives of the contractor who would be responsible for taking instruction from the AAO(Works) shall be communicated to the AAO(Works).
- **21.** The Institute authorized representative may carry periodic instruction and supervision of the work as per directions from the competent authority.
- 22. Any modification in the work schedule shall be informed to the Institute and subsequent payment for such works will be made accordingly on the basis of the final measurements on that specific on the rate quoted.
- 23. Tax deduction at source will be made wherever applicable.
- 24. The quotation will be subject to any further terms and conditions as may be fixed by the Govt of India/ ICAR/Director, ICAR-CIFRI.

- 25. Payment will be released only against the pre-receipted bill submitted in triplicate within 30 days of completion of the works. Payment will be made through RTGS (e-payment). All payments will be made as per prevalent rules and regulations of the Government of India.
- 26. After completion of the work if within 1(one) year and 6(six) months, any defect, or damage of poor workmanship is noticed, the same shall be rectified by the contractor within 10 days failing which Performance Security will be forfeited.
- 27. If more than one bidder happens to quote the same lowest price, firm have more turnover will be awarded the work and if turnover of both firms remains same, the Director, ICAR-CIFRI reserves the right to decide the criteria and further process for awarding the contract, decision of the Director, ICAR-CIFRI shall be final for awarding the contract.
- 28. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tool & plants, water, electricity access, facilities for workers and all other services required for executing the work.
- 29. Ten years guarantee after the completion of the work shall be given by the Contractor for the water proofing treatment. The contractor shall be solely responsible for waterproofing treatment until the expiry of the guarantee period. If any defect is noticed during the guarantee period, it should be rectified by the Contractor within seven days from date of issuing notice by ICAR-CIFRI.
- **30.** The completion report will be addressed to the Accepting Officer. The contractor will make sure that work will be completed in all respect as per specification / scope of works.
- 31. The contractor shall take all precautions to avoid accidents during execution of works. He shall be responsible for all damages and accidents caused to work due to negligence on his part. In case of any accident of the labourers/ contractual staff, the entire responsibility will rest on the contractor and any compensation under such circumstances, if it becomes payable, shall be entirely borne by the contractor.
- 32. The contractor shall not pay wages lower than minimum wages for labour as fixed by the Govt of India/State Govt whichever is higher.

33. LIQUIDITY DAMAGES:

- In all cases of delay by the Contractor in completion of the construction or any part forming them subject matter of this contract beyond the periods specified in purchase order/contract, other than a delay caused by force beyond control (*Force Majure*), the Procuring Entity shall have the right without prejudice to its other remedies under this contract, to claim liquidated damages amounting to 0.5% of the contract/tender value for each week (or part thereof) of delay until actual delivery or performance or completion of works. However, such damages shall not exceed 10% of the delivery price of the goods or services which the delivery or performance has been delayed.
- II. In the event the supplier/agency/contractor terminates the Contract or part of it, the Director, ICAR-CIFRI, Barrackpore shall have the right to procure/hire/construct upon such terms and in such manner as it deems appropriate, goods or services or works similar to those undelivered and the supplier/agency/contractor shall be liable to the Director, ICAR-CIFRI, Barrackpore for any excess cost incurred for procuring similar goods or services or works. However, the supplier shall continue performance of the contract to the extent not terminated.

34. Resolution of disputes:

- i. All disputes, agreements or questions arising out of or in connection with this contract or relating to its construction or performance shall be settled amicably by mutual consultation. If after 90 days, the parties fail to resolve their differences by mutual discussions, the matter shall be referred for arbitration in accordance with the Arbitration and Conciliation Act, 1996.
- ii. The Parties shall continue to perform their obligation under this Contract during the conciliation/arbitration proceedings. The cost of arbitration (including the fees and expenses of the arbitrators) shall be shared equally by the parties, unless the award specifies otherwise.
- iii. This article shall survive the termination of this contract.
- **35. Penalty clause for non execution of work**: In case of failure to execution or undertake the work or completion of work by the Contractor/firm/company as per order, the performance security money deposited by the contractor will be forfeited.
- **36.** Any damage to building, fittings or any other articles etc. done by the contractor of his workman during the execution of the works shall be made good by the contractor at this own cost and nothing extra will be paid to the contractor for the same.
 - **33.**The Director, ICAR-Central Inland Fisheries Research Institute, Barrackpore, Kolkata-700120,West Bengal reserves the right to accept or reject any or all the tenders either in part or in full without assigning any reasons whatsoever.
