EXPRESSION OF INTEREST for Non Exclusive License of Reshmeen Fish Feed

The ICAR-Central Inland Fisheries Research Institute Barrackpore, Kolkata, 700120, West Bengal, India has developed **Reshmeen Fish Feed** Technology. Now the Director, ICAR-CIFRI invites Expression of Interest for commercialization of the same for a period of five years on NON-EXCLUSIVE basis. The detailed terms & conditions are contained in the EOI document attached herewith and also available from the ICAR-CIFRI website www.cifri.res.in.

Technology: Reshmeen Fish Feed

Dry silkworm (Antheraea mylitta) pupa meal contains a good amount of crude protein content in this pupae meal which made them suitable ingredients for inclusion in feed formulation. The optimum lipid requirement of selected freshwater fish species ranged from 4-8%. In Reshmeen feed the lipid was removed from the meal to an extent that will safeguard fish health and increase shelf life.

The basic aspect of the present invention is water stable and floatable *A. mylitta* (Tasar silkworm) pupae meal incorporated floating fish feed. The above-said feed was developed in four pellet sizes of 1mm, 2mm, 3mm, and 4mm diameter having CP ranges from 24 -36% according to the life stages and nutrient requirements of the fish. Reshmeen fish feed, remain stable in the water for a desired duration by keeping its nutrient intact.

The technology has been developed by ICAR-CIFRI, Barrackpore in collaboration with CSB-CTRTI, Ranchi

Advantages

- ❖ In the present invention, *A. mylitta* pupae meal can replace 75% and 100% fish meal protein in the diet of *P. hypophthalmus* and *O. niloticus*, respectively with satisfactory growth performance and nutrient utilization.
- ❖ The A. mylitta (Tasar silkworm) pupae meal-based floating fish feed showed desirable floatability and water stability when broadcast in the water. Hence, supports high nutrient availability for fish for a longer duration.
- ❖ The developed feed showed comparatively better growth performances in fishes compared to selected commercial feed. Therefore, *A. mylitta* (Tasar silkworm) pupae

meal-based floating fish feed proved to be a promising alternative for the fish production sector in the upcoming days.

4. Eligibility Criteria

The bidder(s) should have extensive and proven mix of skill and expertise in the field of manufacture of fisheries and aquaculture products to be used in fish/ animal related industry. The bidder should have previous experience of similar work. The bidder must meet/satisfy the following minimum criteria which should be reflected in the Bid

- 1. The Bidder should have prior experience in manufacturing of Fisheries Feed or products.
- 2. The Organization should have at least Rs. 10, 00,000/- of annual turnover during previous 3 (Three) financial years.
