- 5. Unless a candidate sends Certificate/Provisional Certificate in respect of Graduation & Post Graduation Qualification, his/her application will be summarily rejected.
- 6. The Minimum age will be 21 years and Maximum 45 years with relaxation as per rules.
- 7. Candidates who are already working / or in similar positions should produce no objection certificate obtained from their employer/ supervisor at the time of interview.
